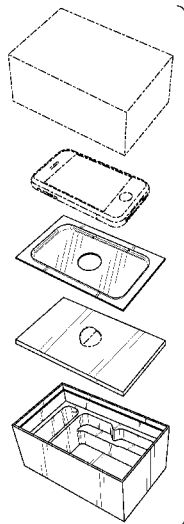

(57) **CLAIM**

The ornamental design for packaging, substantially as shown and described.



DESCRIPTION

FIG. 1 is an exploded perspective view of packaging showing our new design in combination with structures drawn in broken line with which the design may be used;  
 FIG. 2 is a perspective view of the design of FIG. 1 assembled and in a condition of use;  
 FIG. 3 is perspective view of the design of FIG. 1;  
 FIG. 4 is a top perspective view of one portion of the packaging of FIG. 1 shown in a condition of use  
 FIG. 5 is a top perspective view of one portion of the packaging of FIG. 1  
 FIG. 6 is a bottom perspective view of FIG. 5;  
 FIG. 7 is a front view of FIG. 5;  
 FIG. 8 is a rear view of FIG. 5;

 FIG. 24 is another side view of FIG. 20;  
 FIG. 25 is a top plan view of FIG. 20; and,  
 FIG. 26 is a bottom plan view of FIG. 20.

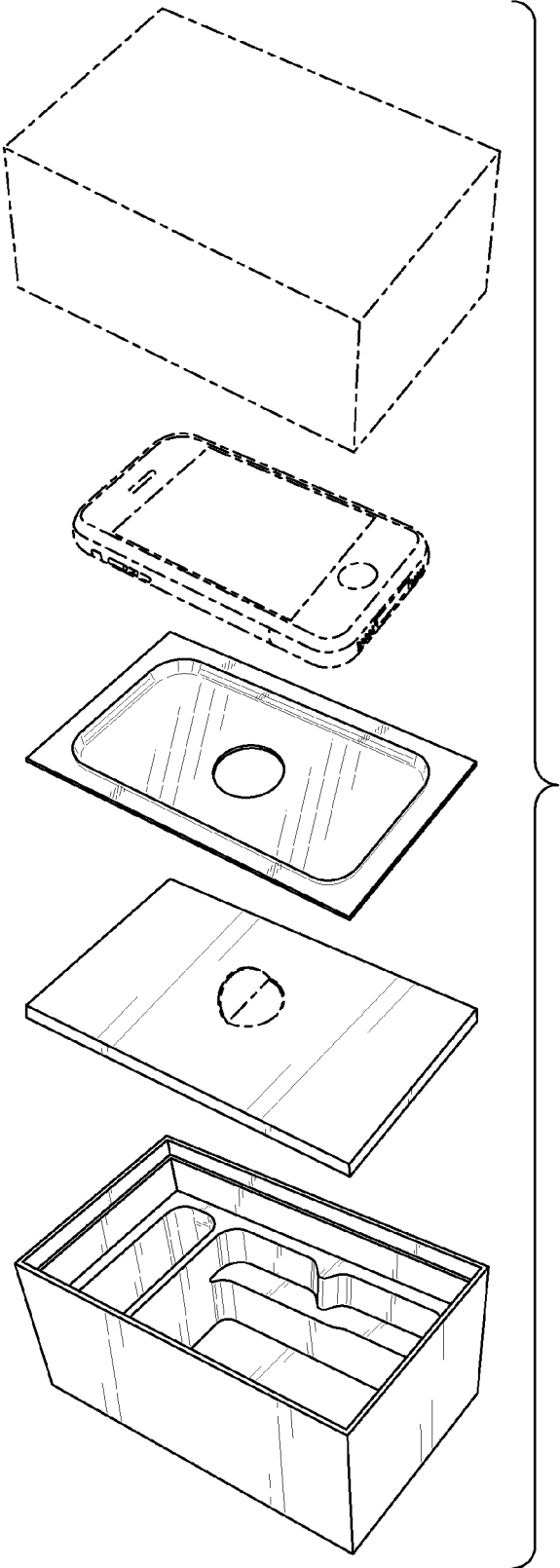

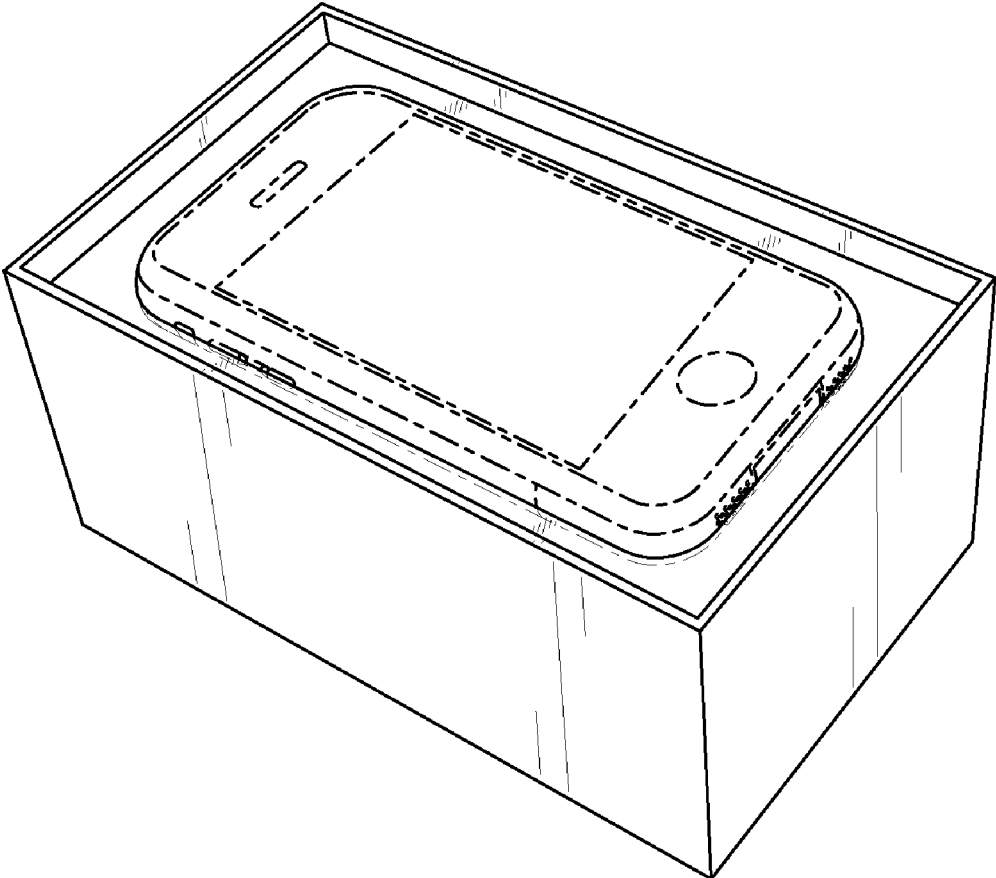

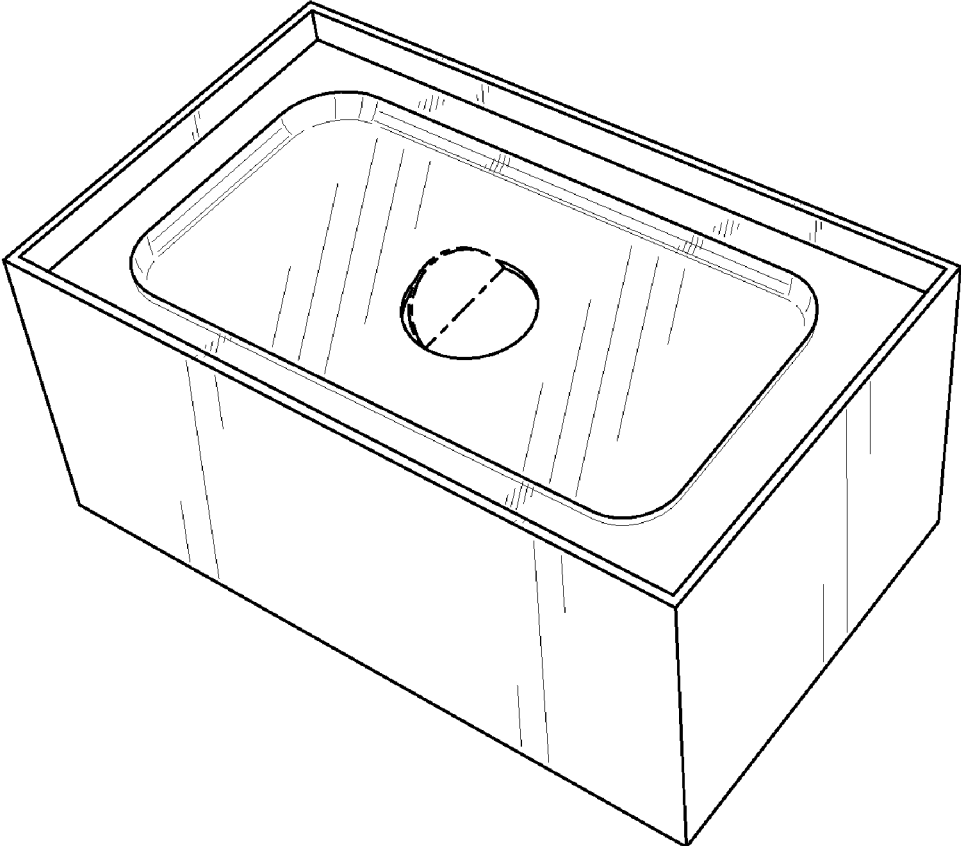

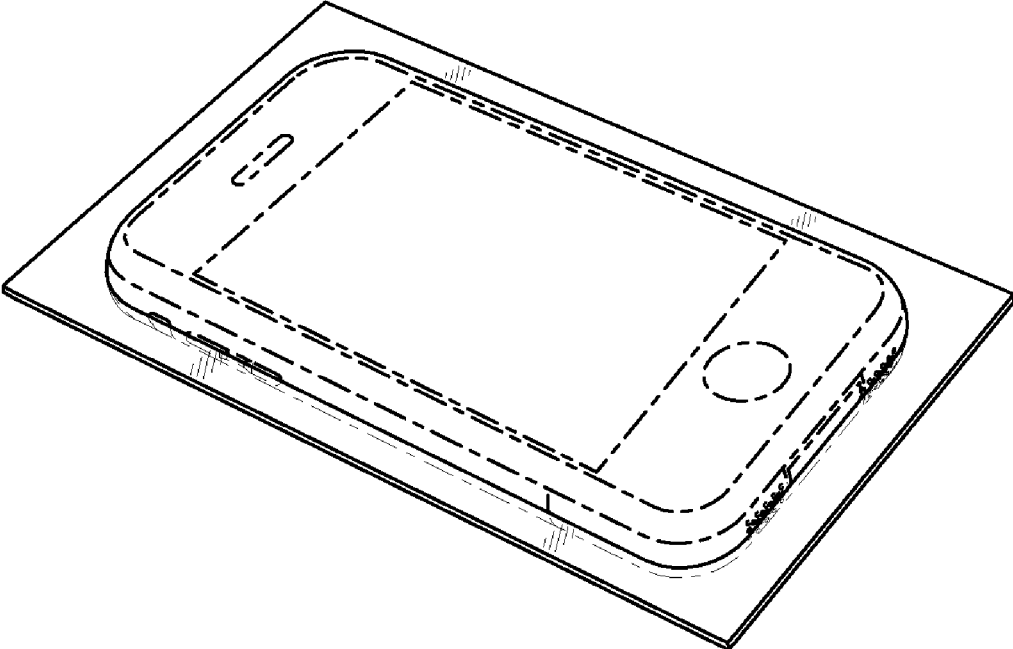

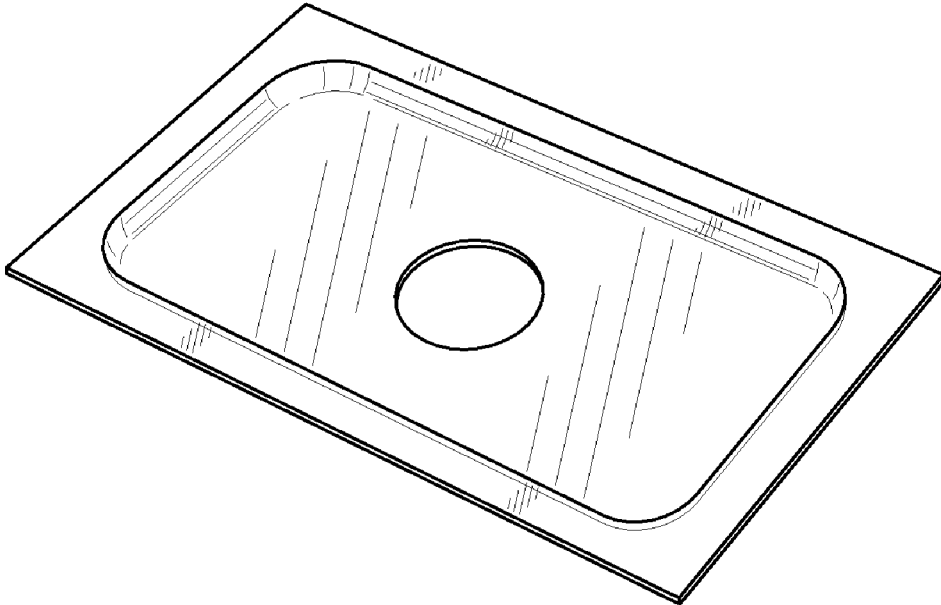

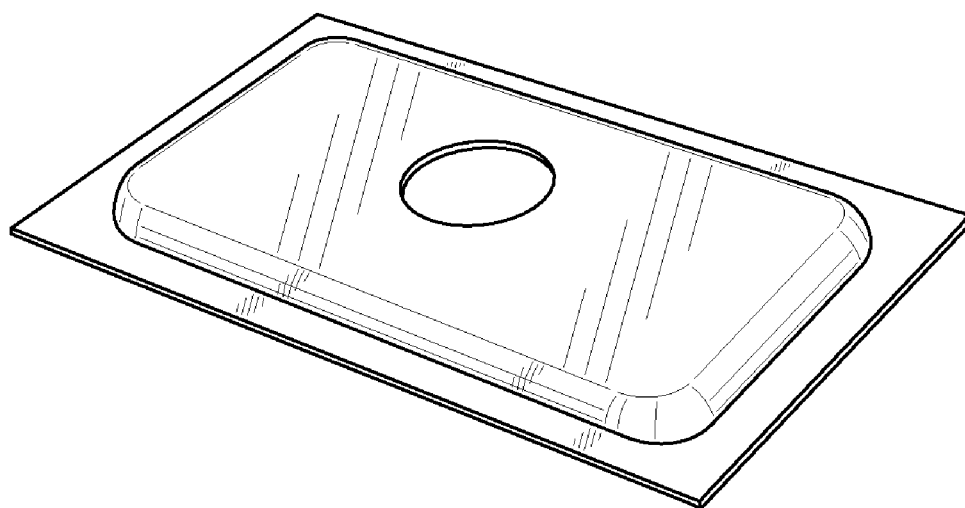

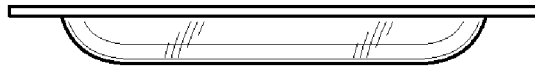

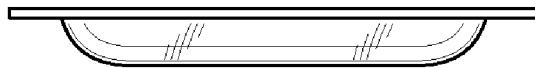

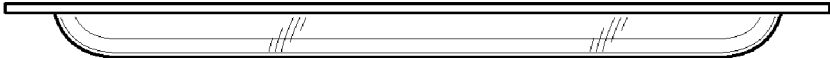

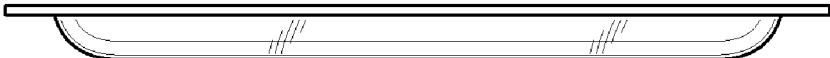

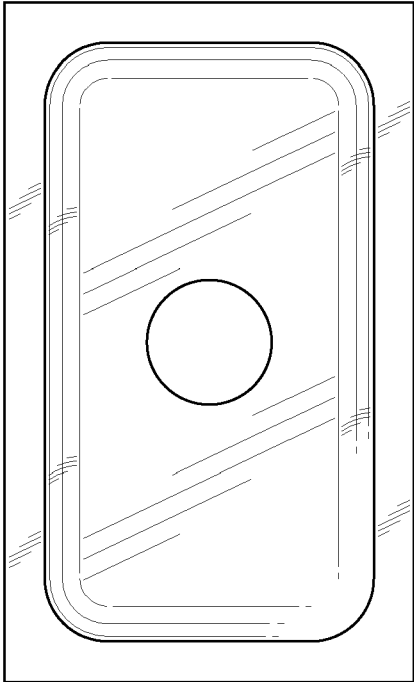

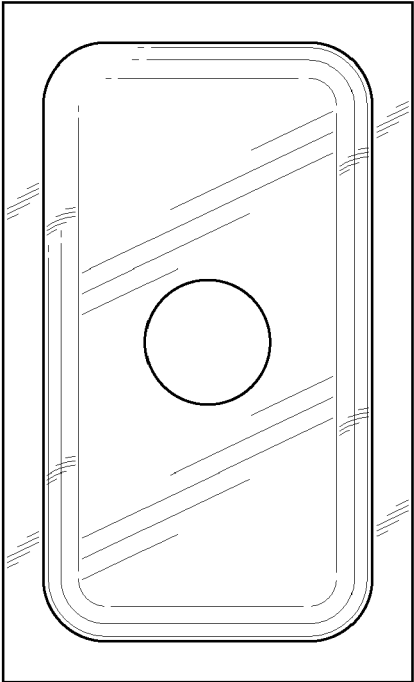

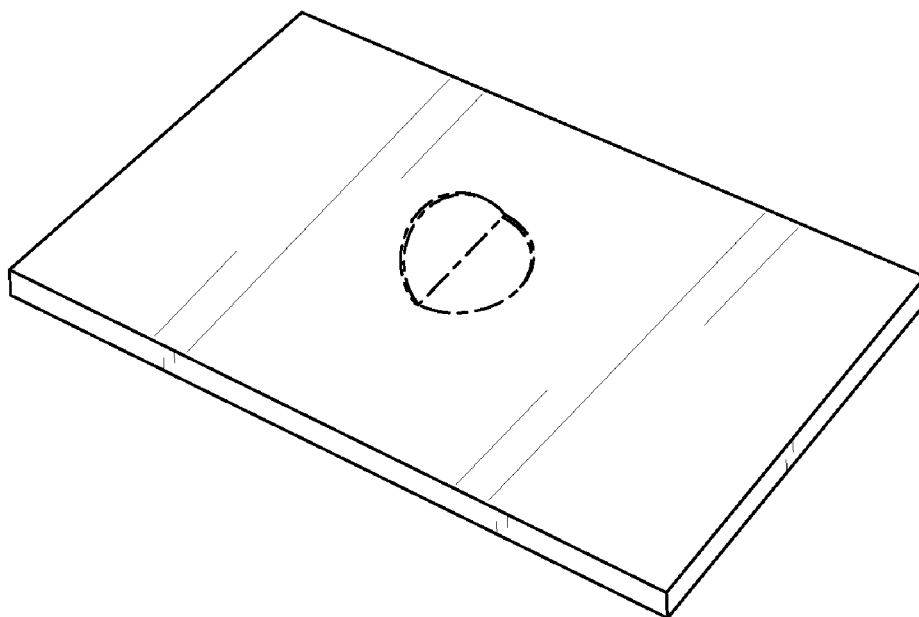

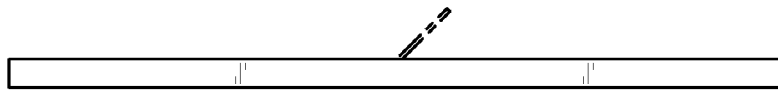

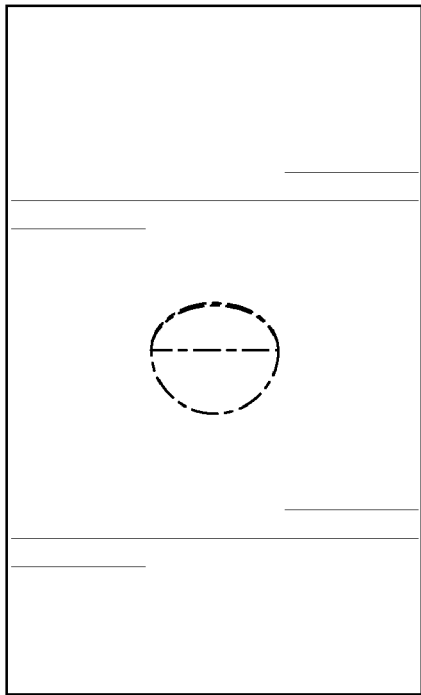

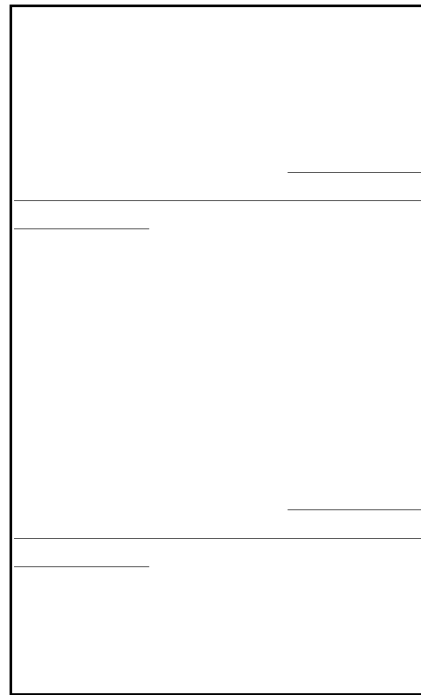

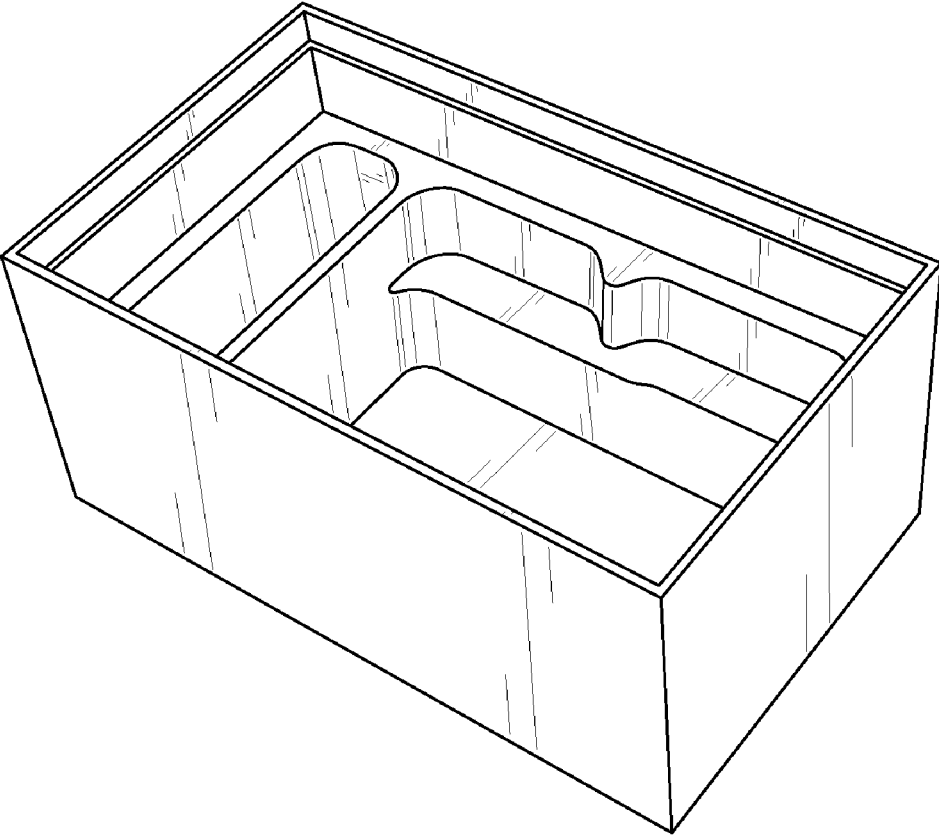

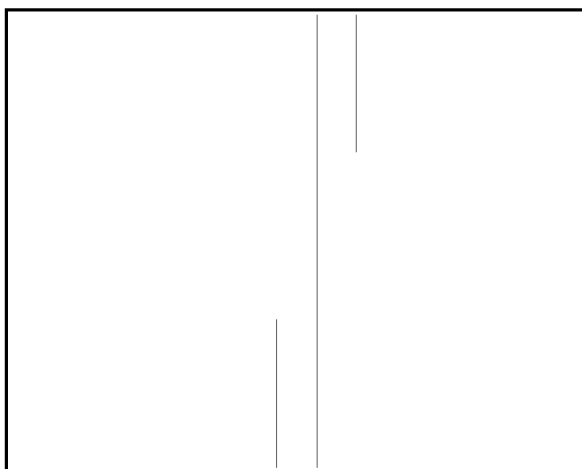

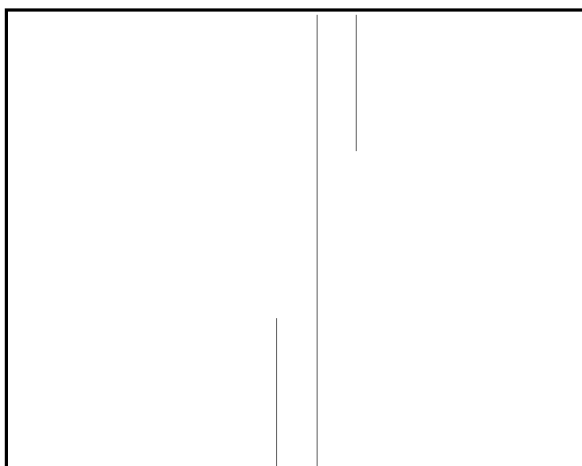

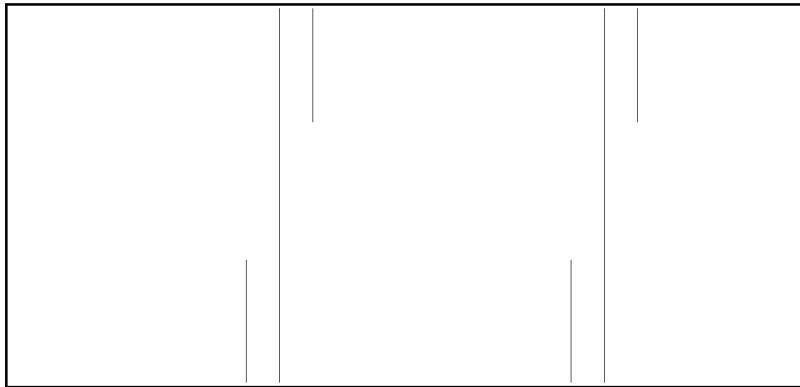

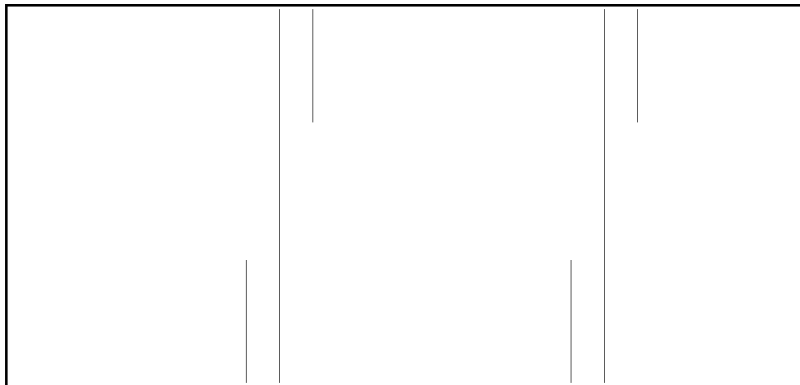

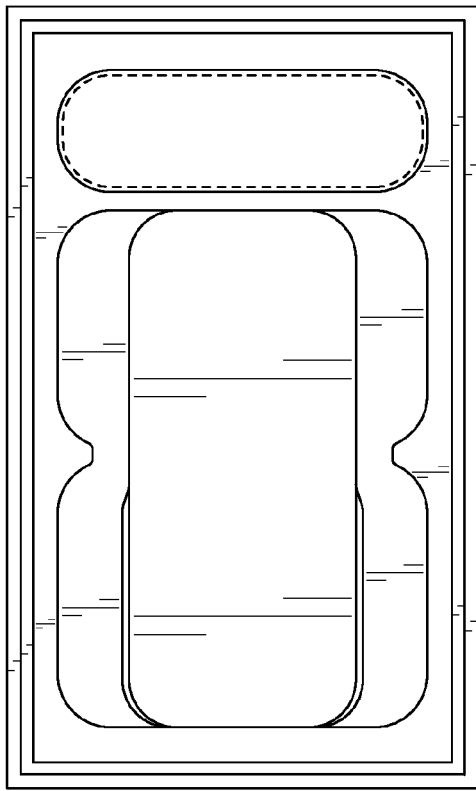

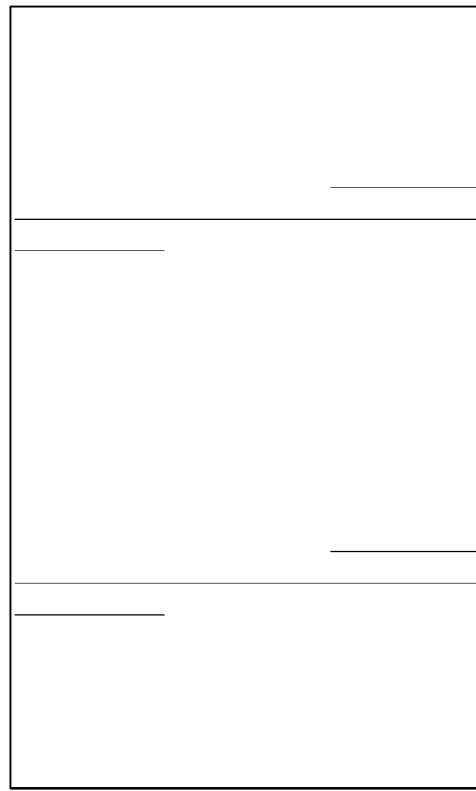
